➤ Webinars

- **Eliminating the Adverse Impact of Alcohol and Drug Use on Children and Families Series** – In partnership with the National Association for Children of Addiction (NACoA) and the JBS TTA team, the OVC offered the following five-part webinar series:
 - *Session 1: Why Focus on Children of Addiction?* – This initial session introduced knowledge acquired through over 40 years of clinical work, developmental research and study, and examination of the environmental history of children growing up with parental addiction.  - *Session 2: Facilitating Recovery for Parents and Children Impacted by Addiction: Using a Whole Family Recovery Strategy* – The second webinar focused on the healing and recovery that comes to the whole family from participation in a structured, evidence-based educational support program and provided participants with a clear understanding of – Celebrating Families!™, its Spanish version, Celebrando Familias!, and a version that was culturally adapted for use with Native American families, Wellbriety Celebrating Families!  - *Session 3: Supporting Children Affected by Parental Addiction* – This webinar provided an overview about the value of educational support groups for children of parents with alcohol/substance use disorders. Presenters also reviewed specifically the benefits of NACoA's Children's Program Kit 2.0, including its impact, flexibility, multi-site and multi-age tool kit and collaboration opportunities.  - *Session 4: Embracing and Engaging Key Systems to Support Children and Families Affected by Addiction* – Session 4 of 5 in the series provided participants with an overview of the multiple systems that can offer other collaborative opportunities to strengthen a lasting inclusion of support for children and families suffering from addiction in the family.  - *Session 5: Multi-generational Addiction and the Children Webinar Resources* – The final webinar session provided an overview on the powerful impact of addiction on the developing child. It reminded participants that each time we focus on the person who is addicted without focusing on the family, we are denying the opportunity for breaking the cycle of addiction. - **Generations United** - In partnership with the [Generations United](#) and the JBS TTA team, the OVC offered the following three webinars:

- *Facing a Pandemic: Grandfamilies Living Together During COVID-19 and Thriving Beyond* – The webinar session discussed how grandfamilies or kinship families are currently navigating two crises – the COVID-19 public health emergency and the opioid epidemic. These crises have heightened the challenges of existing grandfamilies and created new families. The webinar recording, along with resources are accessible via the [link here](#).
- *African American Grandfamilies: Helping Children Thrive Through Connection to Family and Culture* - The webinar session discussed how one in five Black children live with grandfamilies or in kinship care at some point in their lives through the formal foster care system or informal arrangements. The last decade has seen growing reliance by the foster care system on placing children with kin, which is good for families and communities. - *American Indian and Alaska Native Grandfamilies: Helping Children Thrive Through Connection to Family* – The final webinar session explored the importance of AI/AN cultural strengths, tips for connecting meaningfully and authentically with those you seek to serve, helpful services for the families, and recommendations to implement in your community. - *Taming Tough Emotions: How Supervisors and Colleagues Can Respond to Difficult Times* – This session provided introductory content designed to help supervisors and others learn how to use mindfulness and emotional containment strategies to keep themselves in balance, as well as provide the support and hope that their staff and colleagues need during this time.
