2019 SAFE Station Summary Statistics

- 775 patients walked in the door, 686 (88.5%) were transported or linked to care. 83 additional individuals received customized treatment plans by phone.
- 199 encounters were repeat patients (25.7%).
 - Our most loyal customer visited us 6 times.
 - 91 Encounters (45.7%) were individuals that came in 3 or more times.
 - However, 66.1% of 2019 clients only came in the one time.
 - Program to date, 268 repeats with 198 (73.9%) coming in 3 or more times; 694 of the total 1168 incidents (59.4%) were for one-time patients.
- 57% Male, 43% Female (1 transgender female, as far as I know this was our only non-binary/gender non-conforming patient. However there is not a NEMSIRS-recognized data field for this).
- By Race:
 - 86% White
 - 12% Black
 - 1% Asian
 - <1% Indian
 - <1% Hawaiian
- By Residency category:
 - 5% Whitehall
 - 22% Homeless
 - 61% Franklin County
 - 12% Out of Franklin County
 - 2 from out of state (technically, 1 individual from SC twice).
- Residency statistics:
 - The 12% Out of Franklin County came from 16 different counties
 - Most common were Fairfield (31) and Delaware (15).
- By City (top 8 listed):
 - Columbus (383)
 - Whitehall (43)
 - Reynoldsburg (31)
 - Grove City (24)
 - Westerville (19)
 - Canal Winchester (19)
 - Lancaster (15)
 - Pickerington (11)
- The average age has remained stable year-over-year, approximately 32 years, 9 months at the time of assessment.
- By age group:
 - 86% of all patients were between the ages of 20 and 39
 - 8% 40-49
 - 4% were 50 or older.
 - Youngest: 20
 - Oldest: 72

- Medication administration:
 - Narcan was administered to 4 patients
 - 3 were taken to an ED for stabilization
 - 1 continued on to treatment.
 - Ondansetron (Zofran) was administered to 18 patients.

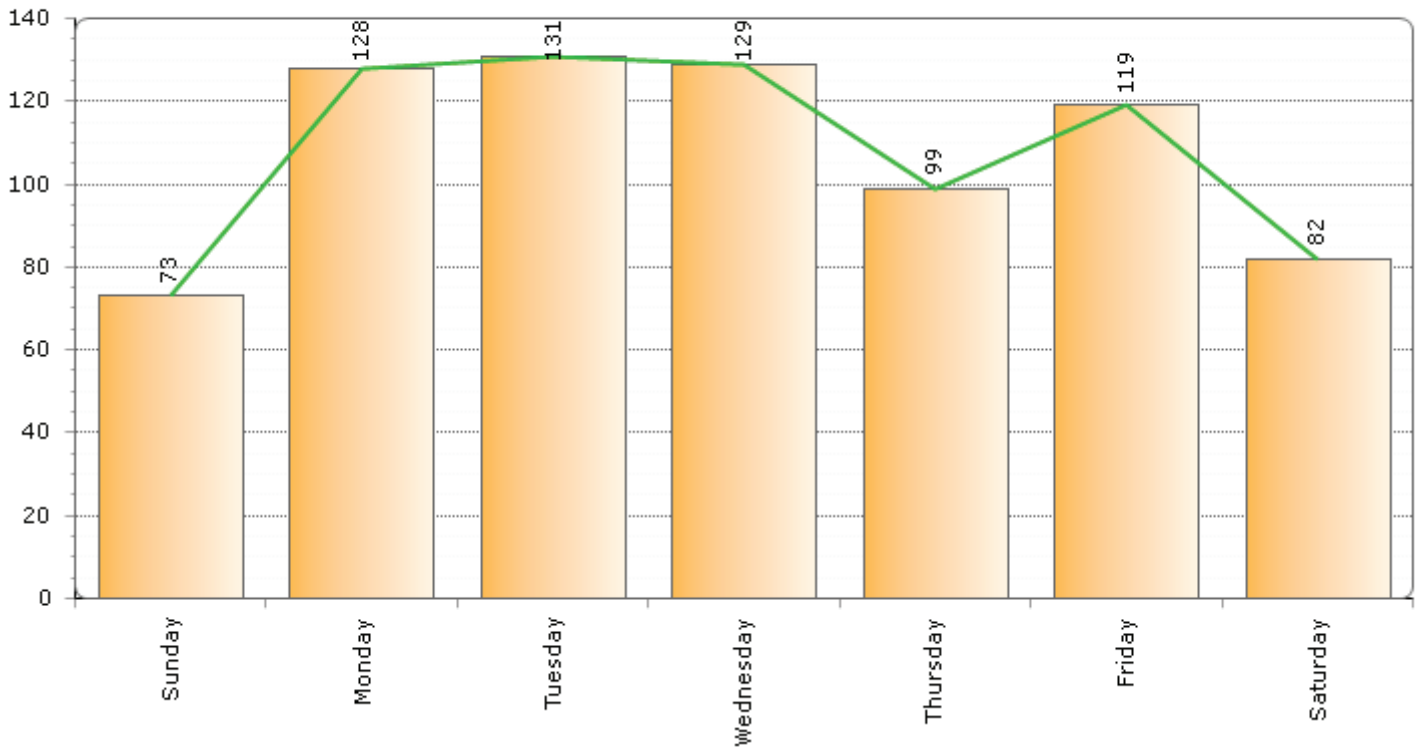

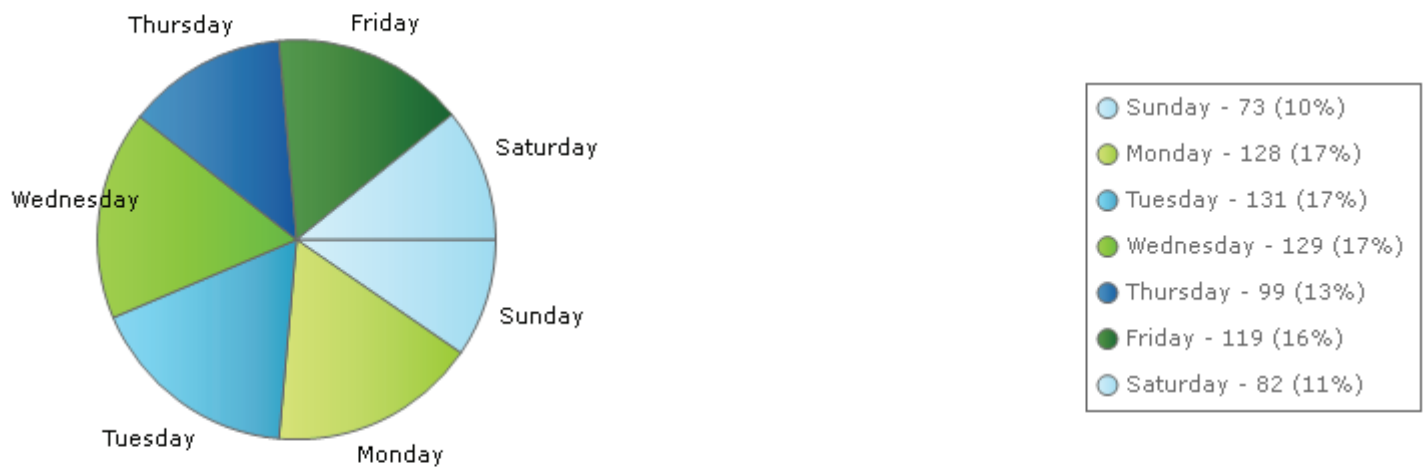
On "On Duty": This internal measurement helps us to understand impact on 9-1-1 crews.
