#### What is the Office of Justice Programs?

- The Office of Justice Programs (OJP)
   provides grant funding, training,
   research, and statistics to the criminal
   justice community.
- OJP is one of three grant-making components of the Department of Justice along with the Office on Violence Against Women (OVW) and the Office of Community Oriented Policing Services (COPS).



#### **Policy Office**

provides national leadership to criminal justice organizations that partner with BJA to identify effective program models for replication and infuse data-driven, evidence-based strategies into operational models, practices, and programs.

#### **Programs Office**

administers state. local, tribal, and territorial grant programs. It acts as BJA's direct line of communication to states, local iurisdictions. territories, and tribal governments by providing customerfocused grants management support and careful stewardship over federal funds.

#### **Operations Office**

coordinates all communication, formulates and executes the budget, manages contracts, measures grantees' performance, and provides administrative support to BJA.

Implement and enhance prescription drug monitoring programs.

#### Collaborate

Develop multidisciplinary projects that leverage key data sets to create a holistic view of the environment and develop interventions based on this information.

#### Increase

Increase the availability of treatment and recovery support services in rural or tribal communities by expanding the use to technology-assisted treatment and recovery support services.



#### Expand

Expand diversion and alternatives to incarceration programs.

#### Connect

Connect survivors of nonfatal overdoses to treatment and recovery services.

#### Coordinate

Support comprehensive crosssystem planning and collaboration.

#### Develop

Develop and implement strategies to identify and provide treatment and recovery support services to "high-frequency" utilizers of multiple systems (e.g., health care, child welfare, criminal justice) who have a history of opioid misuse.

#### **Role of the Programs Office Team**

#### **Award Acceptance**

- The grant award agreement is a legally binding contract with the federal government.
- The Authorized Representative accepts the award electronically in JustGrants.
- TIP: Before the award can be accepted, the Entity Administrator must assign key roles in JustGrants.






### **Award Conditions: OJP Standard Conditions**


- You are responsible for adhering to all award conditions.
- The award conditions numbered 1 through 29 are the OJP standard conditions.

BJA specific award conditions begin at number 30 in the award agreement



## Award Conditions: Withholding Funds

- Withholding award conditions prohibit obligation, expenditure, or draw down of funds until <u>both</u> actions are completed:
  - OJP/BJA approval of missing/revised document
  - Award condition modification (ACM) approved in JustGrants
- Conditional Clearance until budget is approved
- Others as determined by application review




# Award Conditions: Budget Clearance Process

- Budget clearance (BC) grant award modification (GAM) initiated in JustGrants by OCFO
- If changes needed, a BC GAM will be "change requested" and assigned to the award's GAA to make revisions.
- Additional changes may be needed based on BJA review.



# Award Conditions: Budget Clearance Process



- Prizes
- Rewards, entertainment, trinkets, or any other monetary incentives
- Client stipends
- Gift cards
- Vehicle purchases
- Food and beverages





#### Award Conditions: Grants Financial Management Training

- The Grant Award Administrator and Financial Manager assigned to your award must complete training within 120 days of grant acceptance (if it was not previously completed on/after 1/1/2020).
  - If the Grant Award Administrator and/or Financial Manager change, they will have 120 days to complete their training from the day they are added within the JustGrants system.
- For certain recipients, this will be a withholding condition.
- Must be completed every three years

- Submit Grants Financial Management Training certificates to your BJA Grant Manager





#### **Accessing Funds**

In order to access funds, the following actions must be completed:

- Valid award acceptance in JustGrants.
- Removal of all withholding award conditions, if applicable.
- Entity registration in the U.S. Treasury's Automated Standard Application for Payments (ASAP) system.
- Submission of any delinquent reports, if applicable.





#### **Reporting Requirements: Overview**

- Grantees are required to enter data in the PMT on a quarterly schedule (every 3 months).
- COSSAP Performance Measures Questionnaire

- Grantees are required to submit a PDF copy of the PMT report (as an attachment) into the JustGrants system on a semiannual basis or every 6 months, during the October–December and April–June reporting periods (by January 30 and July 30).

#### **Grant Award Modifications (GAM)**

- A GAM is used to request project changes that require prior approval.
- The assigned GAA must submit GAMs in JustGrants.
- GAM types include:
  - Budget Modification
  - Change Project Scope
  - Project Period Extension
  - Sole Source Approval
  - Programmatic Costs

#### **Training and Technical Assistance**

The COSSAP training and technical assistance (TTA) program offers a variety of learning opportunities and assistance to support BJA COSSAP grantees and other local, tribal, and state stakeholders to build and sustain multidisciplinary criminal justice responses to illicit substance use and misuse.

#### TTA may include but is not limited to:

- Facilitating peer-to-peer learning opportunities in which communities can learn from experienced programs through virtual consultations and on-site visits.
- Providing speakers for conferences and workshops or skilled subject-matter experts for training events to educate stakeholders and build capacity.
- Facilitating strategic and cross-system planning to identify community resources, establish priorities, and develop a road map to achieving goals.
- Identifying materials such as policies and procedures, guidelines, and data sharing agreements that support program activities.

When in doubt make a request!



#### **Training and Technical Assistance**

- The COSSAP training and technical assistance (TTA) program includes a core assessment of each grantee related to project goals and activities and areas of needed assistance.
- Coaches from the TTA partners will reach out to help determine what training and assistance can help accomplish your goals in your grant.
- They will also share information on webinars, training materials, communities of practice and mentor sites who can assist you.



## **Coordinating Training and Technical Assistance Provider**



The Institute for Intergovernmental Research (IIR) serves as the connecting point for COSSAP TTA efforts and collaborates with BJA leadership and fellow TTA providers to work directly with COSSAP site-based grantees. IIR's role includes publication production and design; planning, coordination, and delivery of national-level trainings and working group meetings; COSSAP Resource Center website development and maintenance; coordination of distance learning opportunities and resource dissemination; review, distribution, and tracking of TTA requests; coordination of and provision of TTA to six categories of demonstration projects; provision of TTA in the areas of overdose fatality review, harm reduction, and stigma reduction; and coordination of other complementary activities.
